## PFCCO-NATIONAL TERMS AND CONDITIONS

### I. REGISTRATION:

- a. Pre-registration of participant/s is highly encouraged. Pre-registration means that registration fee is duly paid either in cash, check, charged to the Training Subsidy Fund (TSF), or deposited in the NCRL-PFCCO bank account.
- b. No walk-in participant shall be accepted unless the number of registered participants has not reached the maximum number.

### II. CANCELLATION OF TRAINING AND REGISTRATION

- a. To ensure smooth training preparation, cancellation of registration by the participants or cooperatives shall be subject to the following terms and condition:
  - a.1 If cancellation is made five (5) working days before the scheduled training, 50% of the payment shall be forfeited in favor of PFCCO-National to cover training expenses.
  - a.2 If cancellation is made three (3) working days before the scheduled training, the total amount paid shall be forfeited in favor of PFCCO-National to cover the expenses.

NOTE: Participants or cooperatives which may have not made payments in advance but have registered or reserved slots in the trainings shall be billed accordingly.
